A Message from the President:

Hello DC-COPS family. I hope this finds you well as we move into the warmer days of spring. Thank you for taking the time to read through this important newsletter – it's full of useful information about our Survivors' Breakfast, National Police Week, C.O.P.S.' 25th Anniversary Banquet, the popular annual golf tournament for DC-COPS, and much more. The most significant pieces of information to discuss with you are our two upcoming membership meetings and the board elections.

First of all, one thing we don't do enough is offer our gratitude for all the amazing hard-working volunteers who organize or help with our events and serve DC-COPS. I also want to recognize everyone who provides us with financial support throughout the year, no matter how large or small the donation.

It's time to talk about a topic very dear to our hearts: DC-COPS. Our organization is at a major crossroads as it moves into its second decade. I cannot stress enough how pivotal our upcoming member meetings and board elections are. In June 2009, every board position with DC-COPS is going to be open to the membership. Each board position carries a two-year term and because of our organization's by-laws (and other reasons), none of us current directors can run for our positions again. That's a crucial detail. This is

where the board comes in. Therefore, our organization cannot exist, practically and technically, without a board of directors, especially without a president.

What a great and proud moment for our members to 'step up to the plate' and become part of the board! It's been an honor for me to serve our survivors for more than seven years – four of those years as president. Many of our survivors, including the organization's founders, faithfully have served on the board over the past ten years. I can't imagine the metropolitan area without the Washington DC Chapter of Concerns of Police Survivors. I'm hoping to see the continuation of DC-COPS with a new energetic board of directors. You can read details about our two upcoming membership meetings and board position descriptions in this newsletter. Please note the membership form that's included in this mailing for you to fill out, which will help us with the essential task of keeping our database up-to-date and making voting easier. There were many other things I wanted to share with you in my message, but I felt this was most important. DC-COPS needs dedicated individuals to continue its operation and move forward in its support of survivors. It would be a blessing to have no new survivors but reality tells us differently and all of us need to be there. We feel it's an honor to serve on the board and hope you'll feel the same. DC-COPS belongs to all of you.

This election is one of the most important in a long while. All board positions are going to be open to nominees and many of us cannot run again because of term limits. This brings us to the crossroads mentioned in the *President's Message* on the first page of this newsletter. Many of these board positions must be filled for our chapter to continue operation.

newsletter). You can mail the form to the address listed or bring it with you to the Survivors' Breakfast, the May meeting, or the June meeting.

Who is eligible for office?

The same rules that apply to voting also apply to running for office. However, survivors aren't eligible to serve as a board member until at least one year has gone by since the loss of their officer. A board member shall act as an official spokesperson of the chapter, shall serve a two-year term, and shall perform other duties on behalf of the organization as assigned. Board descriptions are as follows:

President: Shall be the presiding chief officer of the Chapter, preside at meetings and/or conferences of the chapter and at meetings of the Executive Board; have the option to call special meetings of the Executive Board when deemed necessary, or upon a petition of a majority of the Executive Board; submit appropriate chapter reports to the Executive Board and the C.O.P.S. Chapter Coordinator; make appointments to the Executive Board should a position become vacant; shall perform other duties on behalf of the organization as he/she deems necessary.

Vice President: Shall fill the position of President should the elected President be unable to complete his/her term; shall coordinate chaplain services for the chapter; shall work with Legislators and various levels of government on behalf of the chapter.

Treasurer: Shall complete necessary State and Federal financial reports required by National C.O.P.S. and submit to the President for review and submission to the C.O.P.S. Chapter Coordinator; shall be responsible for handling all business associated with the bank; promptly deposit all funds; report all expenditures of the Chapter to the membership at the general meeting.

Recording Secretary: Shall take and transcribe minutes of all meetings; providing copies to the Executive Board and to the National Chapter Coordinator; safely keep the Bylaws of this Chapter and keep records of all official amendments; shall prepare, file, and maintain paperwork required by the District of Columbia laws; shall be responsible for the coordination of written communication in the event the Correspondence Secretary is unable.

Correspondence Secretary: Shall be responsible for the coordination of all written communication on behalf of the chapter; shall apprise the National Office of any and all

changes of the membership including names, addresses, phone numbers, etc., in a timely manner; shall take and transcribe minutes of all meetings in the event that the Recording Secretary is unable.

Parliamentarian: Shall ensure compliance to the common usage and customs of Robert's Rules of Order.

Liaison Officer Chair: Shall be responsible for recruiting 'liaison officers' from the many law enforcement agencies in the Washington, DC metropolitan region so that each can communicate information about DC-COPS events with their respective agencies and also act as points of contact in case their department experiences a line of duty death. One of the strongest foundations of our organization is our relationship to the many area agencies and we want to strengthen it further.

Anyone wishing to be nominated for an elected position must submit a letter of intent to President Sterling Spangler with biographical information by Friday, June 19, 2009. It doesn't have to be an essay but we do want to know a little about you and why you'd like to be on the board (if you prefer paper, the letter can be mailed but should be in Sterling's hands by June 19.) If you have access to a computer and an e-mail account, an e-mail attachment is even better! Please address the letter to: Sterling Spangler, *Election Committee Chair*, 3404 Bitterwood Place, #I-303, Laurel, MD 20724 or as an e-mail attachment to president@dc-cops.org.

Please include your contact information such as phone number, mailing address, and relationship to deceased officer. Upon receipt of the letter, a *Nominee's Pledge Form* will be mailed quickly to each candidate. We must have the *Nominee's Pledge Form* in hand at election time on June 27; therefore, it must be returned to Sterling before then or it can be brought with you to the meeting itself. This *Nominee's Pledge Form* must be notarized. You can do that in advance of the elections but we will be sure to have a licensed Notary Public at the meeting to make things easy for you.

Once you are proudly elected to the DC-COPS board, things will move fast! There is a National C.O.P.S. hands-on training retreat for new board members from July 9-12, 2009, at a lodge on beautiful Sunnen Lake in the mountains of Missouri. Travel expenses will be reimbursed by DC-COPS and you will learn more about the organization and meet dozens of other board members from across the country. Each chapter is required to send at least one member and we'd love it to be you. It's a great weekend retreat. You can make your travel arrangements as soon as you're elected and we'll go over the details at the May and June meetings. ❖

National Police Week 2009 Schedule

In 1962, President John F. Kennedy signed a proclamation which designated May 15th as Peace Officers Memorial Day and the week in which that date falls as "Police Week". Every year since, tens of thousands of law enforcement officers from around the world converge on Washington, DC to participate in a number of planned events which honor those that have paid the ultimate sacrifice.

The first official memorial service took place on May 15, 1982. On that date, approximately 125 people gathered in Senate Park to honor 91 law enforcement officers. Over the past 22 years we have honored over 3,000 law enforcement officers from around our nation. Today, the National Peace Officers' Memorial Service has become one in a series of events which includes the Candlelight Vigil, which is sponsored by the National Law Enforcement Officers Memorial Fund (NLEOMF) and seminars sponsored by Concerns of Police Survivors (C.O.P.S.) Traumas in Law Enforcement Seminars

This year's Traumas in Law enforcement seminar was held February 2-4 at the James N. Robey Public Safety Training Center in Marriottsville, Maryland. This three-day seminar was well attended, with over 100 people in attendance.

The Traumas in Law Enforcement seminar involved four presenters over a three-day period, along with a survivor panel. The first day's presentation was from our own Shirley Gibson, one of the founders of DC-COPS and past president of National C.O.P.S. (and mother of MPO Brian T. A. Gibson of the Metropolitan Police Department, EOW: 2/5/97). Shirley candidly shared her experience from the moment of hearing of Brian's shooting and the steps she's taken to rebuild her shattered life. At the end of this day we also heard the survivor experiences of Sterling Spangler (Lt. Thomas Rettberg, EOW: 2/11/00), Lynn Parry (Sgt. Mark Parry, EOW: 1/21/02), Eleanor Allione (Trooper Frances Collender, EOW: 2/6/01), and Sue Nickerson (Officer Michael Nickerson, EOW: 2/13/01). Each story was uniquely tragic and yet they shared how human spirit – and our peers in grief – sustains us and makes us stronger when all we want to do is curl up and die.

The second day we heard from Ed Sulzbak, a retired FBI special agent and profiler. Ed shared with us his extensive experiences with the FBI with both thoughtful reflection and humor. Both of which are necessary when dealing with the traumas that the listeners will someday encounter.

On the final day, Robert Douglas, Executive Director of The National P.O.L.I.C.E. Suicide Foundation, and a retired officer from the Baltimore City Police Department, shared with us his experiences as an officer and also his work in researching and documenting police suicides with future hopes of prevention. And finally, guest speaker Steve Watt kicked off the last session with a large, cowboy style “WHHOOOP” which quickly brought us back to our seats after lunch. Steve was an officer with the Rock Springs, Wyoming Police Department who was shot four times and left for dead in 1982 but survived and now shares his story of recovery with others.

DC-COPS wants to give a special note of thanks to survivor Omar Morales (Officer Marlon Morales, EOW: 6/13/01), who is Executive Chef at The Original Steakhouse and

Sports Theatre. With all his hard work and coordination, his restaurant and suppliers provided incredible lunches for all attendees for two days of the seminar. The food got rave reviews. On the final day, DC-COPS was proud to sponsor the lunch for everyone. We'd like to thank the Maryland Chapter of C.O.P.S. for sponsoring the seminars as well as all attendees, who drove long distances in winter weather to join us for this important event. 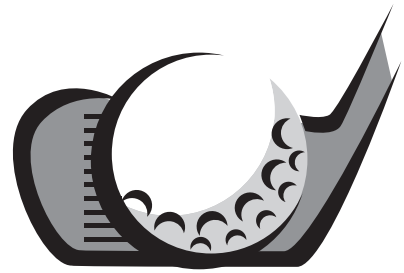

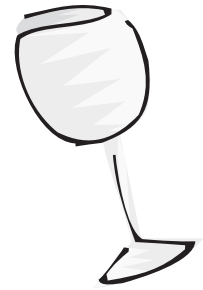
